






Children in families with an open CFS file

Contextualizing the data

- CFS data disproportionally includes Indigenous children
 - Almost 90% of children in care are Indigenous while making up only 25% of the population
 - Systemic bias stemming from colonial systems have contributed to this disproportionate representation and continues to affect the way families interact with child and family services, the health system, and other social services

Contextualizing the data

- This context requires a proportional response and responsibility when working with the data, including:
 - approval from the Health Information Research Governance Committee (FNHSSM)
 - Involving Indigenous partners in the research process and incorporating their input into all aspects of the research
 - Continually centering the values of compassion and decolonization that SPECTRUM works to embody





Figure 1. Study Cohort Development
